Promote your direct-market ag venture in Oregon's Bounty!

Voting or supporting Farm Bureau members (vs. associate "non-farm" members) in good standing are invited to promote their direct-market ag ventures (farm stands, festivals, u-pick fields, CSAs, etc.) in Oregon's Bounty, the biggest and best farm guide for consumers in the state. In April, a printed version of the guide is sent to 61,000 Farm Bureau members in urban and rural areas, and about 3,000 more are distributed at public events throughout the year. A searchable online version at oregonfb.org/oregonsbounty is available year-round for consumers.
